

### MORE ABOUT THE EQUAL RIGHTS AMMENDMENT

One of LWVB'S 2023 goals is "DEMOCRACY". We will have a special emphasis on the Equal Rights Amendment.

<u>ERA Minnesota</u>, a nonprofit volunteer organization, is working to add an Equal Rights Amendment to the Minnesota Constitution through a ballot measure passed by popular vote. In addition, it joins efforts nationwide to enact the ratification of the ERA as the 28th Amendment to the U.S. Constitution.

### The ERA Minnesota is a partner of the LWV Minnesota.

Neither the U.S. Constitution nor the Minnesota Constitution mandates gender equality. The fight to add an Equal Rights Amendment has lasted one hundred years.

The Equal Rights Amendment was first drafted in 1923 by two leaders of the women's suffrage movement. For women's rights advocates, the ERA was the next logical step following the successful campaign to win access to the ballot through the adoption of the 19th Amendment.

### The Equal Rights Amendment reads:

Section 1: Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

Section 2: The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Section 3: This amendment shall take effect two years after the date of ratification.

More recently (2017-2020), a renewed push earned the needed ratification by 38 states, and four additional states have adopted ERAs.

### Raising the ERA From the Dead? | Opinion

A substantial majority of eligible voters today have had no opportunity at all to weigh in on the ERA, considering they were either not born or were under the age of 18 when the nation weighed its passage 50 years ago. Only three states have ratified the ERA with the current electorate. Even one of the ERA's most fervent advocates, the late Supreme Court Justice Ruth Bader Ginsburg, told activists they needed to "put [it] back in the political hopper" and start over.

In 1923 suffragists whose work helped women get the right to vote in 1919 developed what became known as the ERA, a movement to enshrine full equality in the U.S. Constitution regardless of sex. After a long campaign, in 1972 the ERA was passed by both the Senate and the House in 1972. All that was left was for the states to ratify it.

In 2020, Virginia became the 38th and final state required by our Constitution to ratify the ERA. There was a roadblock, though: a decades-old poison pill imposed when Congress passed it in the 1970s, setting a seven-year time limit for ratification. The time limit has no constitutional basis, and recent lawsuits are making that case. While the courts remain locked in debate about the validity of the time limit, one thing is clear: they left the door open to congressional action to lift it. -----

### **RECENT EVENTS**

### Voting rights restored to 50,000 under new Minnesota law.

Surrounded by dozens of formerly incarcerated Minnesotans, advocates and faith leaders, Gov. Tim Walz signed into law a measure restoring the right to vote to felons who have



served out their prison or jail sentences. The law is expected to make 50,000 or more people convicted of felonies but still "on paper" — serving out probation or parole — eligible to vote beginning right away. It is the largest voting rights expansion the state has seen in decades.

#### The MN House passed the "Driver's Licenses for All Bill."

01/31/2022 The MN House passed the "Driver's Licenses for All Bill". It enables unauthorized immigrants to obtain a driver's license and requires that they carry insurance, which makes our roads safer for everyone. Opponents are concerned that the new licenses could be used for fraud, such as signing up for government benefits.

The same day, Gov. Tim Walz will sign into law legislation protecting reproductive freedom and abortion access.
